**Your offer dtd.01.12.2016** for the subject work has been accepted by the Railway Administration at the rates and other conditions mentioned in the Annexure here to attached.

The approximate value of the work at the rates accepted by the Railway works out to **₹ 19,62,300.00 (Rupees Nineteen lakhs Ninety Sixty Two thousand Three hundred only)**. The total Security deposit payable by you works out to **₹98,120/-**. Through **On line using IREPS Net Banking No. PE102153/116112616066691, dtd.26.11.2016 for an amount of ₹ 39,250/-** already submitted by you towards EMD is retained as a part of security deposit. The balance security deposit will be recovered in cash by a percentage deduction ordinarily @ 10% of the periodic payments to be made to you on account of the work done to reach the total security deposit of **₹98,120/-**.

The security deposit shall be released only after the expiry of maintenance period and after passing the final bill as certified by the competent authority based on 'No Claim Certificate'. Please note that no interest will be paid on the amounts deposited/recovered against earnest money and security deposit under this contract. You are also requested to fill and submit "Electronic Fund Transfer Mandate Form" which is enclosed herewith to enable the Railway to release your payments your bank account through EFT since you have not filled and submitted the same along with the tender.

In addition to the security deposit you are required to submit a performance guarantee in the form of an irrevocable bank guarantee equivalent to 5% of the contract value i.e., amounting to **₹98,120/-** within 30(Thirty) days from the date of issue of letter of acceptance (LOA). Extension of time for submission of PG beyond 30 (Thirty) days and upto 60 days from the date of issue of LOA may be given by the Authority who is competent to sign the contract agreement. However, a penal interest of 15% per annum shall be charged for the delay beyond 30(Thirty) days i.e., from 31<sup>st</sup> day after the date of issue of LOA. In case the contractor fails to submit the requisite PG even after 60 days from the date of issue of LOA, the contract shall be terminated duly forfeiting EMD and other dues, if any payable against that contract. The failed contractor shall be debarred from participating in re-tender for that work. The performance guarantee bond should be issued by the Nationalized/Scheduled Banks. The P.G. shall be released after the physical completion of work based on the completion certificate issued by competent authority. Accordingly, the currency of the guarantee should include the currency of contract plus 60 days beyond that. In case the time for completion of work gets extended the contractor should get the validity of performance guarantee extended to cover such extension of time for completion of works plus 60 days beyond that. Accordingly, the performance guarantee bond should be valid upto **08.06.2017** which includes the currency of contract valid upto **08.04.2017** plus 60 days beyond the currency. A copy of Performa for guarantee bond is enclosed herewith for obtaining the same from the Nationalized/Scheduled Banks.

You are required to get yourself registered with Asst. Labour Commissioner(Central) concerned as required under contract Labour (Regulation & Abolition) Act, 1970 and the Contract Labour (Regulation & Abolition) Central Rules, 1971 and obtain License from the Asst. Labour Commissioner(C) concerned and produce the same to this office before signing the Agreement failing which the contract awarded shall be terminated on the ground that you have not complied with legal provisions of the said Act.

The East Cost Railway Unified standard Schedule of Rate'2010 of Woks & materials and Indian railway Unified Standard specification'2010 (Woks & Material), Volume-I and Part-II, III & IV containing General Conditions of Contract and Standard specifications Volume-2 of 2014 with up to date correction slips, and all other conditions incorporated in the tender documents signed by you and the rates and special conditions accepted by the Railway Administration shall form part and parcel of the Agreement.

The rates accepted are inclusive of all charges such as labour, lead, lift, loading, unloading, crossing Railway lines etc., Sales Tax and any other incidental charges leviable by the Government of India/the State Government and other Local Bodies.

Until a formal agreement is executed for this work, this acceptance letter will form as a binding contract between you and Railway Administration subject to modification as may be mutually agreed to.

The contract period is up to **08.04.2017** from the date of issue of acceptance letter. In this connection you are requested to Submit the Accepted Programme of work as per Clause No.19(3) of G.C.C. 2014.

The schedule of work along with special conditions applicable to the contract is enclosed for your information and ready reference to start the work in right earnest. However, necessary required work orders will be issued to you after being approved by the Sr.DEN (Bridges)/E.Co.Railway/WAT. Please contact ADEN/Br/WAT and SSE(Br)/RGDA for further instructions in the subject work.




